

ROAD TRAFFIC REGULATION ACT 1984

THE OLDHAM - BROOK STREET (CHADDERTON) PROHIBITION OF WAITING AMENDMENT ORDER 2000

The Oldham Borough Council, have today made an Order under the Road Traffic Regulation Act 1984, as amended, the effect of which is to amend the Chadderton (Town Centre) (Traffic Regulation) Order, 1973 (herein called the "Principal Order") by deleting from Schedule 2 to the Principal Order the entry contained in Schedule 1 below and substituting into Schedule 2 to the Principal Order the entry contained in Schedule 2 below.

The Order will come into operation on 22nd May 2000.

A copy of the Order and a map showing the lengths of road referred to and a copy of the Council's statement of reasons may be examined at my office between the hours of 8.40am and 5.00pm Mondays to Fridays (Room 222, Civic Centre, West Street, Oldham, Telephone 0161 911 4846, Ref: TO 28/97).

If you wish to question the validity of the Order or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from 17th May 2000 apply to the High Court for the purpose.

**THE OLDHAM - BROOK STREET (CHADDERTON)
PROHIBITION OF WAITING AMENDMENT ORDER 2000**

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act makes the following Order:-

1. This Order shall come into operation on 22nd May 2000 and may be cited as the Oldham - Brook Street Prohibition of Waiting Amendment Order 2000.
2. The Chadderton (Town Centre) (Traffic Regulation) Order, 1973 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though the entry contained in Schedule 1 below be deleted from Schedule 2 to the Principal Order and substituted with the entry contained in Schedule 2 below.
3. This Order shall be construed as one with the Principal Order.
