THE BROADGATE LINK ROAD

(PROHIBITION OF WAITING) ORDER 2002

Made

16 January 2002

Coming into Force

18 January 2002

The Secretary of State for Transport, Local Government and the Regions (a), in exercise of the powers conferred by sections 1 (1) and 2 (1) and (2) of the Road Traffic Regulation Act 1984 (b), and of all other powers enabling him in that behalf, hereby makes the following Order:

- This Order shall come into force on 18 January 2002, and may be cited as The Broadgate Link Road (Prohibition of Waiting) Order 2002.
- 2. In this Order
 - "Broadway" means the A663 (Broadway) in the District of Oldham;
 - "the link road" means the Broadway Business Park Link Road (Broadgate) from the junction with Broadway to a point 110 metres west of the same junction, and
 - "water authority" means water or sewage undertaker within the meaning of the Water Industry Act 1991 (c)
- 3. Subject as mentioned in articles 4 and 5 of this Order, no person shall except on the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any vehicle to wait on the link road.
- 4. Nothing in article 3 of this Order except in the area within 30 metres of the junction with Broadway shall apply -

- so as to prevent a vehicle waiting on the link road, for so long as may be necessary for it to be used in connection with
 - (i) any building operation or demolition,
 - (ii) the removal of any obstruction to traffic,
 - (iii) the maintenance, improvement or reconstruction of the trunk road, or
 - (iv) the laying, erection, inspection, maintenance, alteration, repair, renewal or removal in the or near the link road of any sewer, main, pipe conduit, wire, cable or other apparatus for the supply of gas, water, electricity or any telecommunications apparatus as defined in Schedule 2 to the Telecommunications Act 1984 (a)
- (b) in relation to a vehicle being used -
 - (i) in the service of a local authority or of a water authority in pursuance of their respective statutory powers or duties,-
- 5. Nothing in article 3 of this Order shall apply to
 - (c) a vehicle waiting when the person in control of it is -
 - (ii) required by law to stop,
 - (iii) obliged to stop in order to avoid an accident, or
 - (iv) prevented from proceeding by circumstance outside his control
 - (d) a vehicle being used
 - (i) for fire brigade, ambulance or police purposes
