ROAD TRAFFIC REGULATION ACT 1984

THE OLDHAM (OFF STREET PARKING PLACES)  
VARIATION NO. 38 ORDER 2000

The Oldham Borough Council in exercise of its powers under Sections 32(1) and 35(1), (3) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended, ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on the 12th day of February 2001 and may be cited as the Oldham (Off-Street Parking Places) Variation No. 38 Order 2000.
2. The Borough of Oldham (Off-Street Parking Places) Order 1980 (which Order is hereinafter referred to as "the Principal Order") shall have effect as though the charging hours and rates of charge at the parking place locations referred to in Schedule 1 below be deleted from Schedule 2 to the Principal Order and substituted with the charging hours and rates of charge referred to in Schedule 2 below.
3. This Order shall be construed as one with the Principal Order.

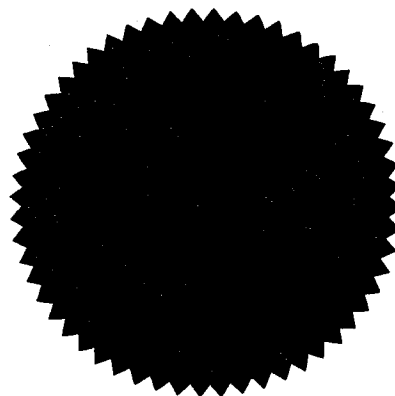

THE OLDHAM (OFF STREET PARKING PLACES)  
VARIATION NO. 38 ORDER 2000

The Oldham Borough Council have today made an Order under the Road Traffic Regulation Act 1984, as amended, the effect of which is to amend the Borough of Oldham (Off Street Parking Places) Order 1980 (hereinafter called "the Principal Order") by deleting from Schedule 2 to the Principal Order at the parking place locations referred to in Schedule 1 below the charging hours and rates of charge contained therein and substituting into Schedule 2 to the Principal Order the charging hours and rates of charge referred to in Schedule 2 below.

Details of the conditions of use are set out in the Schedules to this Notice.

The Order will come into operation on 12th February 2001. A copy of the Order and map showing the parking place referred to and a copy of the Order being amended and the Council's statement of reasons may be examined at my office between 8.40am and 5.00pm Mondays to Fridays (Room 222 telephone 0161 911 4846 Ref: TO/35/00).

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from 30th January 2001 apply to the High Court for the purpose.
