THE OLDHAM (OFF-STREET PARKING PLACES)
VARIATION NO. 35 ORDER 1998

The Oldham Borough Council in exercise of its powers under Sections 32(1), 35(1) and (3) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on the 3rd day of August 1998 and may be cited as the Oldham (Off-Street Parking Places) Variation No. 35 Order 1998.
2. The Borough of Oldham (Off Street Parking Places) Order 1980 (which Order is hereinafter referred to as "the Principal Order") shall have effect as though:-
 - (a) the parking places and conditions attaching thereto referred to in Schedule 1 below are inserted into Schedule 2 to the Principal Order;
 - (b) the new Scale referred to in Schedule 2 below is added to Schedule 3 to the Principal Order;
 - (c) the terms and conditions attaching to parking place 68 (the open air car park at the Tommyfield Market) in Schedule 2 to the Principal Order are varied as set out in Schedule 3 below;
 - (d) the Article referred to in Schedule 4 below is added to the Principal Order.
3. This Order shall be construed as one with the Principal Order.
