

OLDHAM BOROUGH COUNCILROAD TRAFFIC REGULATION ACT 1984THE OLDHAM - OFF STREET PARKING PLACES
(VARIATION NO. 39) ORDER 2001

The Oldham Borough Council in exercise of its powers under Sections 32(1) and 35(1), (3) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended, ("the Act" and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 21st January, 2002 may be cited as the Oldham - Off-Street Parking Places (Variation No.39) Order 2001.
2. The Borough of Oldham (Off-Street Parking Places) Order 1980 (which order is hereinafter referred to as "the Principal Order") shall have effect as though the car park and provisions relating to it referred to in the Schedule below are inserted into Schedule 2 of the Principal Order.
3. The exemption referred to in Article 41 to the Principal Order shall not apply to Parking Place No.75 referred to in the Schedule below.
4. This Order shall be construed as one with the Principal Order.

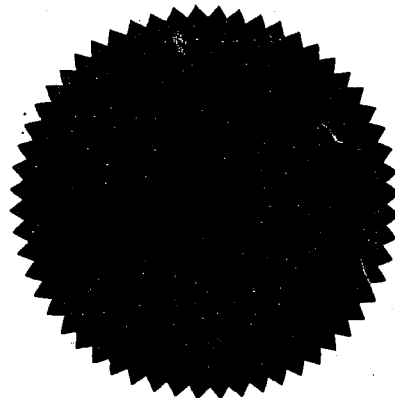

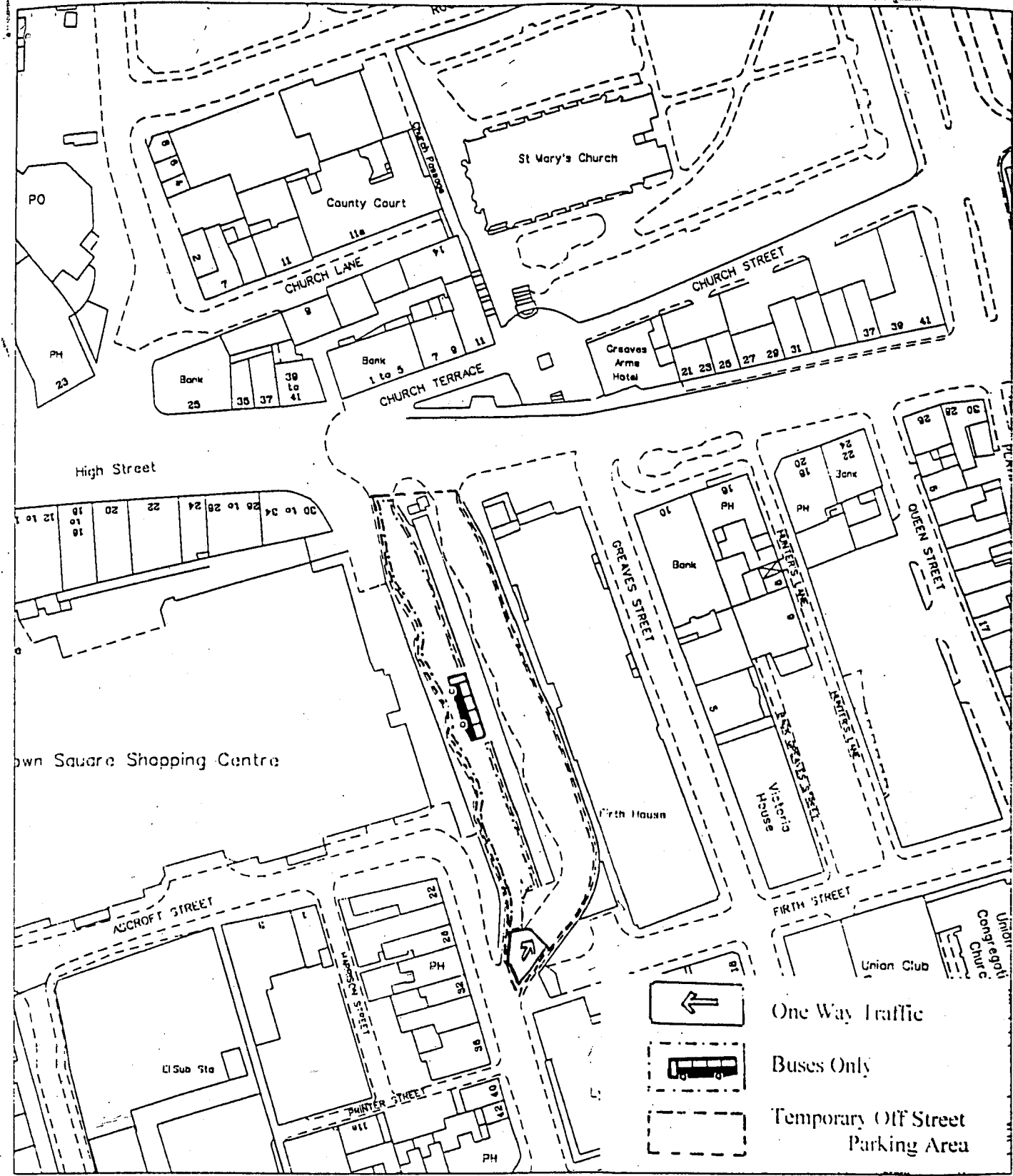
