

OLDHAM BOROUGH COUNCILROAD TRAFFIC REGULATION ACT 1984THE OLDHAM - GREENGATE STREET/WATERLOO STREET  
PROHIBITION OF WAITING EXPERIMENTAL AMENDMENT ORDER 2001

The Oldham Borough Council in exercise of its powers under Sections 9 and 10 of the Road Traffic Regulation Act 1984, as amended, ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 28th June 2001 and may be cited as the Oldham - Greengate Street/Waterloo Street Prohibition of Waiting Experimental Amendment Order 2001 and will continue in force until 27th June 2002.
2. The County Borough of Oldham (Waterloo Street and Greengate Street) (Prohibition of Waiting and Restriction of Loading and Unloading) Order, 1972 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though the entry contained in Schedule 1 below be deleted from Schedule 1 to the Principal Order and the entries contained in Schedule 2 below be substituted into Schedule 1 to the Principal Order.
3. This Order shall be construed as one with the Principal Order.
4. The Executive Director, Environment and Transportation for Oldham Borough Council or any other person authorised by him, if it appears to him or that person to be essential in the interests of the expeditious, convenient and safe movement of traffic, and after:-
  - (i) consulting the Chief Constable of Greater Manchester Police, and
  - (ii) giving such public notice as the Secretary of State may direct,may make modifications of any description to this Order (other than additions) or suspend it.
5. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.

## SCHEDULE 1

- (i) To prohibit waiting on both sides of Waterloo Street from Woodstock Street to Glodwick Road and on both sides of Greengate Street from its junction with Glodwick Road to a point 5 metres south west of Waterloo Street.

**SCHEDULE 2**

**Prohibition of Waiting**

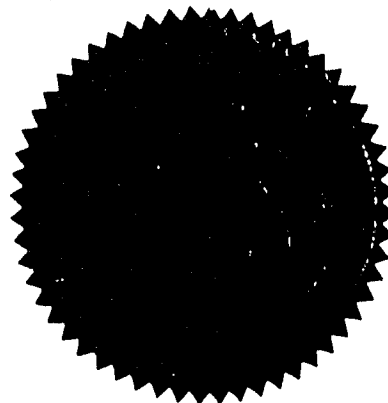
<u>Road</u>	<u>Length</u>	<u>Sides</u>
(i) Greengate Street	From its junction with Barlow Street for a distance of 15 metres in a south westerly direction.	North West
Greengate Street	From its junction with Barlow Street for a distance of 25 metres in a south westerly direction.	South East
Greengate Street	From a point 10 metres north east of its junction with South Hill Street to a point 10 metres south west of that junction.	Both
Greengate Street	From a point 10 metres north east of its junction with Chief Street to a point 85 metres south west of that junction.	South East
Greengate Street	From a point 10 metres north east of its junction with Preston Street to a point 10 metres south west of that junction.	North West
Greengate Street	From its junction with Waterloo Street for a distance of 10 metres in a north easterly direction.	Both
Waterloo Street	From Woodstock Street to Glodwick Road.	Both
