THE OLDHAM (OLDHAM AREA CONSOLIDATION ORDER) PROHIBITION OF WAITING AMENDMENT NO. 46 ORDER 2007

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act makes the following Order:-

- 1. This Order shall come into operation on 23rd April 2007 and may be cited as the Oldham (Oldham Area Consolidation Order) Prohibition of Waiting Amendment No. 5 Order 2006.
- 2. The Oldham Area Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order" shall have effect as though the "at any time" waiting restrictions detailed in the Schedule hereto were contained in the Principal Order at Part 1 Schedule 1.
- 3. This Order shall be construed as one with the Principal Order.
