THE OLDHAM - (ROYTON AREA CONSOLIDATION ORDER) PROHIBITION OF WAITING AMENDMENT NO.10 ORDER 2005

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act makes the following Order:-

- 1. This Order shall come into operation on 9th January 2006 and may be cited as the Oldham (Royton Area Consolidation Order) Prohibition of Waiting Amendment No. 10 Order 2005.
- 2. The Oldham Royton Area Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order" shall have effect as though the disabled parking places detailed in the Schedule hereto were contained in Part 2 Schedule 4 of the Principle Order.
- 3. This Order shall be construed as one with the Principal Order.
