# THE OLDHAM (OLDHAM AREA CONSOLIDATION ORDER) PROHIBITION OF WAITING AND PERMITTED PARKING ORDER AMENDMENT NO. 25 ORDER 2005

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act makes the following Order:-

- 1. This Order shall come into operation on 21<sup>st</sup> October 2005 and may be cited as the Oldham (Oldham Area Consolidation Order) Prohibition of Waiting Amendment Order 2005..
- 2. The Oldham (Oldham Area) Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order" shall have effect as though the details in Schedule 1 be added to Part 1, Schedule 1 of the Principal Order and the details in Schedule 2 be deleted from the Principal Order. The details in Schedule 3 are to be included at Part 1 Schedule 2 of the Order.
- 3. This Order shall be construed as one with the Principal Order.
