THE OLDHAM BOROUGH COUNCIL (OLDHAM AREA) CONSOLIDATION ORDER
PARKING PLACES (OFF STREET) AND PARKING PLACES SCALES (OFF STREET)
AMENDMENT ORDER NO. 2008

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act makes the following Order:-

1. This Order shall come into operation on 20th November 2008 and may be cited as the Oldham Borough Council (Oldham Area) Consolidation Order Parking Places (Off Street) and Parking Places Scales (Off Street) Amendment Order No. 2008.
2. The Oldham Borough Council (Oldham Area) Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order" shall have effect as though the Parking Places (Off Street), as detailed in the First Schedule hereto are inserted into Part II Schedule 5a of the Principal Order and the Parking Places Scales (Off Street) detailed in the Second Schedule hereto are inserted into Part II Schedule 5b of the Principal.
3. This Order shall be construed as one with the Principal Order.

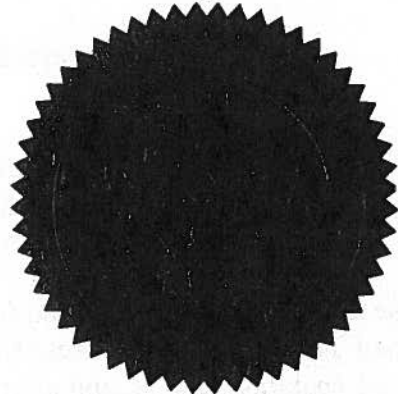
