## **ROAD TRAFFIC REGULATION ACT 1984**

## THE OLDHAM (FAILSWORTH AREA CONSOLIDATION ORDER) PROHIBITION OF WAITING AMENDMENT ORDER NO.9 2008

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act makes the following Order:-

- 1. This Order shall come into operation on 15<sup>th</sup> May 2008 and may be cited as the Oldham (Failsworth Area Consolidation Order) Prohibition of Waiting Amendment Order 2008.
- 2. The Oldham Failsworth Area Consolidation Order 2006 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though the prohibition of waiting restrictions as detailed in the Schedule below were inserted at Part 1, Schedule 1 of the Principal Order.
- 3. This Order shall be construed as one with the Principal Order.
