PROPOSED TRAFFIC REGULATION ORDER

THE OLDHAM BOROUGH COUNCIL (CROMPTON AREA) CONSOLIDATION ORDER
PROHIBITION OF WAITING AMENDMENT NO. ORDER 2008

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act makes the following Order:-

1. This Order shall come into operation on 1st July 2008 and may be cited as the Oldham Borough Council (Crompton Area) Consolidation Order Prohibition of Waiting Amendment No. Order 2008.
2. The Oldham Borough Council (Crompton Area) Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order" shall have effect as though the "at any time" waiting restrictions detailed in the First Schedule hereto are deleted from Part 1, Schedule 1 of the Principal Order, the "at any time" waiting restrictions detailed in the Second Schedule hereto are inserted into Part 1, Schedule 1 of the Principal Order.
3. This Order shall be construed as one with the Principal Order.

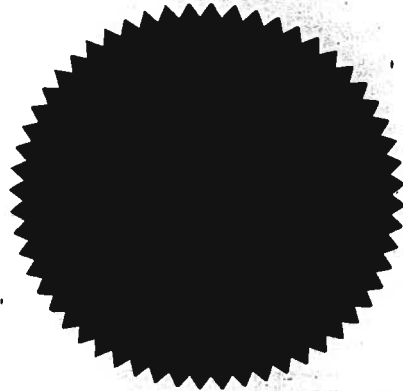
