ROAD TRAFFIC REGULATION ACT 1984

THE OLDHAM (OLDHAM AREA)
CONSOLIDATION ORDER EXPERIMENTAL AMENDMENT ORDER 2010

The Oldham Borough Council in exercise of its powers under Section 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulations Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

1. This Order shall come into operation on 17th February 2010 and may be cited as the Oldham (Oldham Area) Consolidation Order Experimental Amendment Order 2010 and will continue in force until 16th August 2010.
2. The Executive Director for Economy, Skills and Places for Oldham Borough Council may, if that officer considers it essential in the interests of the expeditious, convenient and safe movement of traffic or for preserving or improving the amenities of the area through which any road affected by this Order runs, and after consulting with the Chief Officer of Police, modify or suspend this Order, or any provision thereof, at any time.
3. The Oldham Crompton Area (which Order is thereafter referred to as the "Principal Order") shall have effect as through the items detailed in Schedule 1 hereto are deleted from the Principal Order and replaced with the items detailed in Schedule 2 hereto and the items detailed in Schedule 3 hereto are inserted into the Principal Order at Part 11 Schedule 3a the waiting restrictions detailed in the First Schedule hereto are deleted from the Principal Order at Part 1 Schedule 1 and replaced with the waiting restrictions detailed in the Second Schedule hereto.
4. This Order shall be construed as one with the Principal Order.

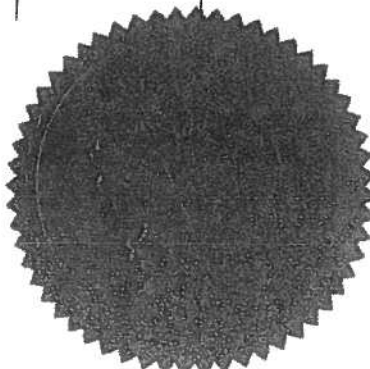
