## **ROAD TRAFFIC REGULATION ACT 1984**

### THE OLDHAM - ROYTON AREA CONSOLIDATION ORDER <u>AMENDMENT NO. 21 ORDER 2011</u>

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- 1. This Order shall come into operation on 22<sup>nd</sup> August 2011 and may be cited as the Oldham Royton Area Consolidation Order Amendment No 210rder 2011.
- 2. The Oldham-Royton Area Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though the waiting restrictions detailed in the First Schedule hereto are deleted from the Principal Order at Part 1 Schedule 1 and replaced with the waiting restrictions detailed in the Second Schedule hereto and the Residents Parking Places detailed in Third Schedule hereto are in included in the Principal Order at Part I Schedule 3a and the Parking Places (Specified Classes of Vehicle) detailed in the Fourth Schedule hereto are included in the Principal Order at Part II Schedule 4 from the date hereof.
- 3. This Order shall be construed as one with the Principal Order.
