

OLDHAM BOROUGH COUNCIL**ROAD TRAFFIC REGULATION ACT 1984****THE OLDHAM - FAILSWORTH AREA CONSOLIDATION ORDER
AMENDMENT NO 17 ORDER 2011**

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 3rd October 2011 and may be cited as the Oldham – Failsworth area Consolidation Order Prohibition of Waiting Amendment No 17 Order 2011.
2. The Oldham – Failsworth Area Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though the waiting restrictions detailed in the Schedule hereto are included in the Principal Order at Part 1 Schedule 1
3. This Order shall be construed as one with the Principal Order.

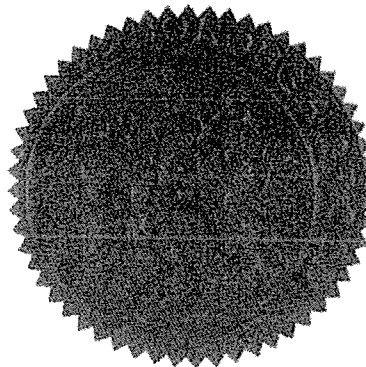

BUS STOP CLEARWAY – BRIERLEY AVENUE FAILSWORTH

The Oldham Borough Council give notice under the Road Traffic Regulation Act 1984 as amended by the Traffic Signs Regulations General Directions 2002 that a Bus Stop Clearway will be introduced on the south side of Brierley Avenue from a point 128 metres south west of its junction with Ashton Road East for a distance of 19 metres in a south westerly direction and on the north side of Brierley Avenue from a point 171.6 metres south west of its junction with Ashton Road East for a distance of 19 metres in a south westerly direction the hours of operation being 7am to 7pm.

The bus stop clearway will conform and will be signed in accordance with the Traffic Signs Regulations and General Direction 2002 and will come into operation on 3rd October 2011

A plan showing the location of the bus stop clearway can be inspected between the hours of 9am and 5pm Monday to Friday at Civic Entrance, Civic Centre, Oldham under reference LJM/TO11/11 (Telephone 0161 770 4836).
