ROAD TRAFFIC REGULATION ACT 1984

**THE OLDHAM - SADDLEWORTH AREA CONSOLIDATION ORDER
AMENDMENT NO 25 ORDER 2012**

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 28th June 2012 and may be cited as the Oldham -- Saddleworth Area Consolidation Order Amendment No25 Order 2012
2. The Oldham-Saddleworth Area Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though the waiting restrictions detailed in the First Schedule hereto are included in the Principal Order at Part I Schedule 1 and the Permitted Parking detailed in the Second Schedule hereto are included in the Principal Order at Part I Schedule 2 and the Parking Places (specified classes of vehicle) detailed in the Third Schedule hereto are included in the Principal Order at Part II Schedule 4 from the date hereof.
3. This Order shall be construed as one with the Principal Order.
