THE OLDHAM – CLIVE ROAD & PROPPS HALL DRIVE FAILSWORTH PROHIBITION OF STOPPING ORDER 2012

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 28th November 2012 and may be cited as the Oldham – Clive Road & Propps Hall Drive Failsforth Prohibition of Stopping Order 2012
2. Save as provided in Article 3 no person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any vehicle to stop during the times specified in the Schedule below in any of the sides of lengths of roads specified in the said Schedule to this Order.
3. (1) Nothing in Article 2 shall render it unlawful to cause or permit any vehicle to stop in any of the sides of lengths of roads referred to therein for so long as may be necessary to enable:-
 - (a) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:-
 - (i) building or demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the lengths of roads or any other adjacent length of road;
 - (iv) the laying, erection, alteration or repair in, or in land adjacent to, the length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in Schedule 2 to the Telecommunications Act 1984;
 - (b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or a water authority in pursuance of statutory powers or duties;
 - (c) the vehicle to be used for fire brigade, ambulance or police purposes.
4. The prohibition and restriction imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.

Mandatory School Keep Clear Markings

<u>Clive Road</u> (south west side) From a point 47 metres north west of its junction with Ogden road for a distance of 70 metres in a north westerly direction	Mon – Fri 8am-5pm	B1, B3, B4, C & E
<u>Clive Road</u> (south west side) From a point 81 metres south east of its junction with Propps Hall Drive for a distance of 32 metres in a south easterly direction	Mon – Fri 8am-5pm	B1, B3, B4, C & E
<u>Clive Road</u> (west side) From its junction with Propps Hall Drive for a distance of 18 metres in a south easterly direction	Mon – Fri 8am-5pm	B1, B3, B4, C & E
<u>Propps Hall Drive</u> (south side) From its junction with Clive road for a distance of 78 metres in a south westerly direction	Mon – Fri 8am-5pm	B1, B3, B4, C & E
