ROAD TRAFFIC REGULATION ACT 1984

THE OLDHAM – FAILSWORTH AREA PROHIBITION OF WAITING AMENDMENT NO 21 ORDER 2012

The Oldham Borough Council in exercise of its powers under Section 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulations Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

1. This Order shall come into operation on 28th November 2012 and may be cited as the Oldham – Failsworth Area Prohibition of Waiting Amendment No.21 Order.
2. The Oldham – Failsworth Area Consolidation Order 2003 (which Order is thereafter referred to as the "Principal Order") shall have effect as through the waiting restrictions detailed in the Schedule hereto are included in the Principal Order at Part 1 Schedule 1 from the date hereof
3. This Order shall be construed as one with the Principal Order.
