**THE OLDHAM - OLDHAM AREA CONSOLIDATION ORDER PROHIBITION OF WAITING
AMENDMENT NO 110 ORDER 2013**

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 13th May 2013 and may be cited as the Oldham – Oldham Area Consolidation Order Prohibition of Waiting Amendment No 110 Order 2013
2. The Oldham-Oldham Area Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though the waiting restrictions detailed in the Schedule hereto are included in the Principal Order at Part 1 Schedule 1 from the date hereof.
3. This Order shall be construed as one with the Principal Order.

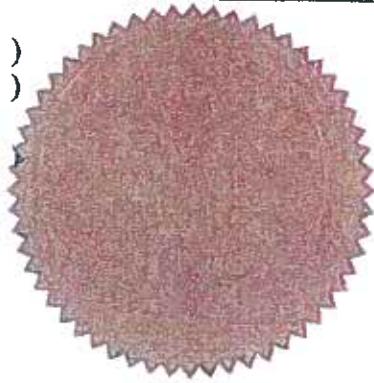

**THE OLDHAM THOMAS STREET & WEST STREET LEES
WAITING & STOPPING ORDERS 2013**

The Oldham Borough Council, have today made Orders under the Road Traffic Regulation Act 1984, as amended, the effect of which is to introduce "at any time" waiting restrictions on the west side of Thomas Street from a point 10 metres south of its junction with West Street to a point 10 metres north of its junction with West Street and on both sides of West Street from its junction with Thomas Street from a distance of 8 metres in a westerly direction and prohibit stopping on Monday to Friday 8am to 5pm on the south side of West Street at the entrance to St Thomas Primary School on the School entrance markings.

The Orders will come into operation on 13th May 2013

A copy of the Orders and maps showing the lengths of road referred to and a copy of the Council's statement of reasons may be examined at my office between the hours of 8.40am and 5.00pm Mondays to Fridays (Civic Entrance), Civic Centre, West Street, Oldham, Telephone 0161 770 4836 Ref: LJM/TO13/8

If you wish to question the validity of the Order or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from the date hereof apply to the High Court for the purpose.
