### THE OLDHAM FURTHERWOOD ROAD RESIDENTS ONLY PARKING ORDER 2013

The Oldham Borough Council, have today made an Order under the Road Traffic Regulation Act 1984, as amended, the effect of which is to introduce 'residents only' parking on all days and at all times on both sides of Furtherwood Road for its whole length from the junction of Sheepfoot Lane and Westhulme Way in a westerly direction and on both sides of Prestbury Drive for its whole length from the junction of Colville Road in an easterly direction and on both sides of Colville for its whole length from the junction of Furtherwood Road in a southerly direction and on both sides of Kenwood Road for its whole length from the junction of Furtherwood Road in a southerly direction and on both sides of Boundary Park Road for its whole length from the junction of Furtherwood Road in a southerly direction.

The Order will come into operation on 29th July 2013

## THE OLDHAM - OLDHAM AREA CONSOLIDATION ORDER RESIDENT'S PARKING ZONE AMENDMENT NO 112 ORDER 2013

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- 2. The Oldham Oldham Area Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though the Resident's Parking Zone detailed in the Schedule below is included in the Principal Order at Part II Schedule 3b
- 3. This Order shall be construed as one with the Principal Order.
