**HUDDERSFIELD ROAD & RIPPENDEN ROAD DENSHAW SPEED LIMIT ORDER 2013**

The Oldham Borough Council, have today made an Order under the Road Traffic Regulation Act 1984, as amended, the effect of which is to reduce the speed limit to 30 miles per hour on **Huddersfield Road (A640)** from its junction with Ripponden Road (A672) for a distance of 560 metres in an easterly direction and reduce the speed limit to 40 miles per hour on **Huddersfield Road (A640)** from a point 560 metres east of its junction with Ripponden Road (A672) for a distance of 1.32 kilometres in a north easterly direction and reduce the speed limit to 50 miles per hour on **Huddersfield Road (A640)** from a point 1.88 kilometres northeast of its junction with Ripponden Road (A672) to the boundary with Kirklees- a distance of 2 kilometres

The Order will come into operation on 29<sup>th</sup> July 2013

If you wish to question the validity of the Order or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from the date hereof apply to the High Court for the purpose.

**THE OLDHAM – HUDDERSFIELD ROAD DENSHAW SPEED LIMIT ORDER 2013**

Oldham Borough Council in exercise of its powers under Section 84(1) and (2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 29<sup>th</sup> July 2013 and may be cited as the Oldham – Huddersfield Road Denshaw Speed Limit Order 2013
2. The Oldham-Variou Roads (30MPH and 40MPH) Speed Limit Order 2000 shall have effect as though the items detailed in the First Schedule below are deleted from the date hereof
3. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the length of road detailed in the Second Schedule below
4. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the length of road detailed in the Third Schedule below
5. No person shall drive any motor vehicle at a speed exceeding 50 miles per hour on the length of road detailed in the Fourth Schedule below

**FIRST SCHEDULE**

Items to be deleted from The Oldham –Variou Roads (30mph and 40mph) Speed Limit Order 2000, Schedule 2, Part 1, 30mph

HUDDERSFIELD ROAD (640) DENSHAW extending from its junction with Ripponden Road for a distance of 380 metres east of this point

Items to be deleted from the Oldham-Variou Roads (30mph and 40mph) Speed Limit Order 2000 Schedule 2, Part 2, 40mph

HUDDERSFIELD ROAD (A640) DENSHAW extending from a point 350 metres east of its junction with Ripponden Road to a point 650 metres east of this location

**SECOND SCHEDULE**

**30 MILES PER HOUR SPEED LIMIT**

Huddersfield Road (A640) Denshaw – from its junction with Ripponden Road (A672) Denshaw for a distance of 560 metres in an easterly direction

**THIRD SCHEDULE**

**40 MILES PER HOUR SPEED LIMIT**

Huddersfield Road (A640) Denshaw from a point 560 metres east of its junction with Ripponden Road (A672) Denshaw for a distance of 1.32 kilometres in an easterly direction

**FOURTH SCHEDULE**

**50 MILES PER HOUR SPEED LIMIT**

Huddersfield Road (A640) Denshaw from a point 1.88 kilometres northeast of its junction with Ripponden Road (A672) Denshaw to the boundary with Kirklees, a distance of 2.00 kilometres
