3 Crib Lane, Dobcross. Both sides.

From its junction with Platt Lane, for a distance of

5 metres in a north-westerly direction.

4 Crib Fold, Dobcross. Both sides.

From its junction with Platt Lane, for a distance of

10 metres a northerly direction.

5 Sandy Lane, Dobcross. Both sides.

From its junction with Platt Lane, for a distance of

15 metres in a north-easterly direction.

6 The Square, Dobcross. All sides of The Square.

7 Sugar Lane, Dobcross. North-east side.

From its junction with The Square, for a distance

of 45 metres in a south-easterly direction.

8 Sugar Lane, Dobcross. South-west / south side.

From its junction with The Square, for a distance of 150 metres in a south-easterly and then

easterly direction.
