ORDER 2013**

The Oldham Borough Council, have today made an Order under the Road Traffic Regulation Act 1984, as amended, the effect of which is to introduce 'residents only' parking on Monday–Saturday between the hours of 8am and 8pm on both sides of Putney Close for the whole length from the junction with Booth Hill Lane in a northerly and north easterly direction

The Order will come into operation on 9<sup>th</sup> September 2013

If you wish to question the validity of the Order or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from the date hereof apply to the High Court for the purpose.

RESIDENT'S PARKING ZONE  
AMENDMENT NO 113 ORDER 2013**

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 9<sup>th</sup> September 2013 and may be cited as the Oldham – Oldham – Oldham Area Consolidation Order Resident's Parking Zone Amendment No. 113 Order 2013.
2. The Oldham – Oldham Area Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though the Resident's Parking Zone detailed in the Schedule below is included in the Principal Order at Part II Schedule 3b
3. This Order shall be construed as one with the Principal Order.
