# THE OLDHAM - OLDHAM AREA CONSOLIDATION ORDER AMENDMENT NO 98 ORDER 2012

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- This Order shall come into operation on 28<sup>th</sup> June 2012 and may be cited as the Oldham – Area Consolidation Order Prohibition of Waiting Amendment No 98 Order 2012.
- 2. The Oldham Area Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though the waiting restrictions detailed in the First Schedule hereto are deleted from the Principal Order and replaced with the "at any time" waiting restrictions and loading restrictions detailed in the Second Schedule hereto from the date hereof.
- 3. This Order shall be construed as one with the Principal Order.
