### **OWLER LANE CHADDERTON**

The Oldham Borough Council, have today made an Order under the Road Traffic Regulation Act 1984, as amended, the effect of which is to

Owler Lane Chadderton - remove the existing waiting restrictions on the north west side of Owler Lane from a point 13 metres north east of its junction with Hollinwood Avenue to its junction with Mough Lane which are currently 7am to 9am and 4pm to 6:30 pm on Monday to Friday and replace them with "at any time" waiting restrictions on the north west side of Owler Lane from a point 13 metres north east of its junction with Hollinwood Avenue to its junction with Welbeck Avenue.

The Order will come into operation on 18<sup>th</sup> November 2013

If you wish to question the validity of the Order or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from the date hereof apply to the High Court for the purpose.

THE OLDHAM – CHADDERTON AREA CONSOLIDATION ORDER PROHIBITION OF WAITING AMENDMENT No 33 ORDER 2013

The Oldham Borough Council in exercise of its powers under Sections 9 and 10 of the Road Traffic Regulations Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

- This Order shall come into operation on 18<sup>th</sup> November 2013 and may be cited as the Oldham – Chadderton Area Consolidation Order Prohibition of Waiting Amendment No 33 Order 2013
- 2. The Oldham Chadderton Area Consolidation Order 2003 (which Order is thereinafter referred to as the "Principal Order") shall have effect as though the waiting restrictions detailed in the First Schedule hereto are deleted from the Principal Order at Part 1 Schedule 1 and replaced with the waiting restrictions detailed in the Second Schedule hereto from the date hereof
- 3. This Order shall be construed as one with the Principal Order.
