**THE OLDHAM CHADDERTON AREA CONSOLIDATION ORDER PROHIBITION OF
WAITING AMENDMENT ORDER 2013**

WALLIS STREET CHADDERTON

The Oldham Borough Council, have today made an Order under the Road Traffic Regulation Act 1984, as amended, the effect of which is to

Wallis Street Chadderton – introduce 'at any time' waiting restrictions on the west side of Wallis Street from a point 27 metres north of its junction with Butler Green for a distance of 56 metres in a northerly direction and on the east side of Wallis Street from a point 29 metres north of its junction with Butler Green for a distance of 19 metres in a northerly direction and on the east side of Wallis Street from a point 5 metres south of Mellor Way to its junction with Nelson Way

The Order will come into operation on 18th November 2013

A copy of the Order and a map showing the lengths of road referred to and a copy of the Council's statement of reasons may be examined at my office between the hours of 8.40am and 5.00pm Mondays to Fridays (Civic Entrance), Civic Centre, West Street, Oldham, Telephone 0161 770 4836 Ref: LJM/TO30/12).

If you wish to question the validity of the Order or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from the date hereof apply to the High Court for the purpose.

THE OLDHAM – CHADDERTON AREA CONSOLIDATION ORDER PROHIBITION OF WAITING AMENDMENT NO 34 ORDER 2013

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 18th November 2013 and may be cited as the Oldham – Chadderton Area Consolidation Order Prohibition of Waiting Amendment No 34 Order 2013
2. The Oldham-Oldham Area Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though the waiting restrictions detailed in the Schedule hereto are included in the Principal Order at Part 1 Schedule 1 from the date hereof.
3. This Order shall be construed as one with the Principal Order.
