COOPER STREET & WAINWRIGHT CLOSE SPRINGHEAD

The Oldham Borough Council, have today made an Order under the Road Traffic Regulation Act 1984, as amended, the effect of which is to

<u>Cooper Street/Wainwright Close Springhead</u> – introduce 'at any time' waiting restrictions on the west side of Cooper Street from a point 10 metres south of its junction with Wainwright Close to a point 10 metres north of its junction with Wainwright Close and on both sides of Wainwright Close from its junction with Cooper Street in a westerly direction for a distance of 10 metres

The Order will come into operation on 18th November 2013

If you wish to question the validity of the Order or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from the date hereof apply to the High Court for the purpose.

THE OLDHAM – SADDLEWORTH AREA CONSOLIDATION ORDER PROHIBITION OF WAITING AMENDMENT NO 30 ORDER 2013

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- 1. This Order shall come into operation on 18th November 2013 and may be cited as the Oldham Saddleworth Area Consolidation Order Prohibition of Waiting Amendment No 30 Order 2013
- 2. The Oldham-Oldham Area Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though the waiting restrictions detailed in the Schedule hereto are included in the Principal Order at Part 1 Schedule 1 from the date hereof.
- 3. This Order shall be construed as one with the Principal Order.


