## **ROAD TRAFFIC REGULATION ACT 1984**

THE OLDHAM – RIPPONDEN ROAD & DUMFRIES AVENUE DENSHAW EXPERIMENTAL PROHIBITION OF WAITING ORDER 2013

The Oldham Borough Council have today made an Order under the Road Traffic Regulation Act 1984, as amended, the effect of which is to introduce "at any time" waiting restrictions on the north west side of Ripponden Road from a point 35 metres north east of its junction with Dumfries Avenue to a point 32 metres south west of that junction and on both sides of Dumfries Avenue from its junction with Ripponden Road for a distance of 14 metres in a north westerly direction

The Order will come into operation on 13<sup>th</sup> December 2013 for a period of 18 months.

The Executive Director, Economy Places & Skills for Oldham Borough Council or any person authorised by him, if it appears to him or that person to be essential in the interests of the expeditious, convenient and safe movement of traffic, and after:-

- (i) consulting the Chief Constable of Greater Manchester Police, and
- (ii) giving such public notice as the Secretary of State may direct,

may make modifications of any description to this Order (other than additions) or suspend it.

The Council will consider in due course whether or not to continue the Order in force indefinitely. Within a period of 6 months from the coming into force of this Order any person may object to the making of an Order for the purposes of such indefinite continuation.

Appropriate exemptions are included in the Order.

Any such objections should be sent to the Environment Group Solicitor, Oldham Council, Civic Centre, West Street, Oldham OL1 1UT in writing, stating the title of the Order to which they relate and the grounds for making them.

The Order and a map showing the length of road referred to and a Statement of the Council's Reasons for making the Order may be examined at my office between the hours of 8.40am and 5.00pm Mondays to Fridays (Civic Entrance Tel. 0161 770 4836 Ref: TO13/35) during the objection period.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from the date hereof apply to the High Court for the purpose.

THE OLDHAM – RIPPONDEN ROAD & DUMFRIES AVENUE DENSHAW EXPERIMENTAL PROHIBITION OF WAITING ORDER 2013

The Oldham Borough Council in exercise of its powers under Sections 9 and 10 of the Road Traffic Regulations Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

- This Order made on 6<sup>th</sup> December 2013 shall come into operation on 13<sup>th</sup> December 2013 and may be cited as the Oldham Ripponden Road & Dumfries Avenue Experimental Prohibition of Waiting Order 2013 and will continue in force for 18 months
- 2. The Oldham Oldham Area Consolidation Order 2003 (which Order is thereinafter referred to as the "Principal Order") shall have effect as through the waiting restrictions detailed in the Schedule below are included in Part I Schedule 1 of the Principal Order from the date hereof.
- 3. This Order shall be construed as one with the Principal Order.
