## **GATEWAY CRESCENT CHADDERTON**

The Oldham Borough Council, have today made an Order under the Road Traffic Regulation Act 1984, as amended, the effect of which is to introduce at any time waiting restrictions on the south east and north east side of Gateway Crescent from its junction with Broadgate at the M60 slip road roundabout for a distance of 491 metres in a north easterly and north westerly direction and on the north west and south west sides from its junction with Broadgate at the M60 slip road roundabout for its full length

The Order will come into operation on 10<sup>TH</sup> January 2014

If you wish to question the validity of the Order or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from the date hereof apply to the High Court for the purpose.


The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- This Order made on 10<sup>th</sup> January 2014 shall come into operation on 10<sup>th</sup> January 2014 and 1. may be cited as the Oldham - Chadderton Area Consolidation Order Prohibition of Waiting Amendment No 35 Order 2014
- The Oldham-Oldham Area Consolidation Order 2003 (which Order is hereinafter referred to 2. as the "Principal Order") shall have effect as though the waiting restrictions detailed in the Schedule hereto are included in the Principal Order at Part 1 Schedule 1 from the date hereof.
- 3. This Order shall be construed as one with the Principal Order.
