The Oldham Borough Council, have today made an Order under the Road Traffic Regulation Act 1984, as amended, the effect of which is to:-

<u>Hardman Lane</u> – introduce waiting restrictions on all days between 8am and 6pm on the north east side of Hardman Lane from a point 15 metres south east of Hale Lane for a distance of 14 metres in a south easterly direction and on the north east side of Hardman Lane from a point 13 metres north west of Old Road for a distance of 33 metres in a north westerly direction.

The Order will come into operation on 10th January 2014

If you wish to question the validity of the Order or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from the date hereof apply to the High Court for the purpose.

THE OLDHAM - FAILSWORTH AREA CONSOLIDATION ORDER PROHIBITION OF WAITING AMENDMENT NO 25 ORDER 2014

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- This Order made 10th January 2014 shall come into operation on 10th January 2014 and may be cited as the Oldham – Failsworth Area Consolidation Order Prohibition of Waiting Amendment No 25 Order 2013.
- 2. The Oldham Failsworth Area Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though the waiting restrictions detailed in the Schedule below are included in the Principal Order at Part 1 Schedule 1 from the date hereof
- 3. This Order shall be construed as one with the Principal Order.
