**THE OLDHAM – STOCKFIELD ROAD CHADDERTON WIDTH RESTRICTION ORDER
2014**

The Oldham Borough Council, have today made an Order under the Road Traffic Regulation Act 1984, as amended, the effect of which is to:-

Stockfield Road prohibit any vehicle the width of which (inclusive of any load on the vehicle) exceeds 6 feet 6 inches to proceed in the length of Stockfield Road which extends from its junction with Melbourne Street for a distance of 10 metres in a north westerly direction

The Order will come into operation on 10th January 2014 .

A copy of the Order and a map showing the lengths of road referred to and a copy of the Council's statement of reasons may be examined at my office between the hours of 8.40am and 5.00pm Mondays to Fridays (Civic Entrance), Civic Centre, West Street, Oldham, Telephone 0161 770 4836 Ref: LJM/TO13/16

If you wish to question the validity of the Order or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from the date hereof apply to the High Court for the purpose.

**THE OLDHAM – STOCKFIELD ROAD CHADDERTON
WIDTH RESTRICTION ORDER 2014**

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1) and 2(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order made 10th January 2014 shall come into operation on 10th January 2014 and may be cited as the Oldham – Stockfield Road Chadderton Width Restriction Order 2014.
2. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.
3. No person shall cause or permit any vehicle the width of which (inclusive of any load) of the vehicle) exceeds six feet 6 inches to proceed in the length of Stockfield Road which extends from its junction with Melbourne Street for a distance of 10 metres in a north westerly direction
