**THE OLDHAM BOROUGH COUNCIL (OLDHAM AREA) CONSOLIDATION ORDER 2003**  
**AMENDMENT ORDER NUMBER 117 2014**

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2), 4(2), 32, 35, 45 and 46 of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 7<sup>th</sup> February 2014 and may be cited as the Oldham Borough Council (Oldham Area) Consolidation Order 2003 Amendment Order Number 117 2014.
2. The Oldham Borough Council (Oldham Area) Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though the provisions contained in Schedules 1 to 4 to this Order were deleted from the Principal Order and the provisions contained in Schedules 5 and 8 to this Order were inserted into the Principal Order.
4. This Order shall be construed as one with the Principal Order.
