# THE OLDHAM – FAILSWORTH AREA CONSOLIDATION ORDER PERMITTED PARKING & RESIDENTS PARKING PLACES <u>AMENDMENT No 30 ORDER 2014</u>

The Oldham Borough Council in exercise of its powers under Section 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulations Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

- 1. This Order shall come into operation on 9th September 2014 and may be cited as the Oldham Failsworth Area Consolidation Order Permitted Parking & Residents Parking Places Amendment No 30 Order 2014.
- 2. The Oldham Failsworth Area Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though The Residents Parking Places detailed in the First Schedule below are deleted from the Principal Order at Part Il Schedule 3a and replaced with the Residents Parking Places detailed in the Second Schedule below and the Permitted Parking detailed in the Third Schedule below is included in the Principal Order at Part Schedule 2 of the Principal Order from the date hereof
- 3. This Order shall be construed as one with the Principal Order.




