**THE OLDHAM - FAILSWORTH AREA CONSOLIDATION ORDER PROHIBITION OF WAITING
AMENDMENT No 29 ORDER 2014**

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

This Order shall come into operation on 9th September 2014 and may be cited as the Oldham Failsworth Area Consolidation Order Prohibition of Waiting Amendment No 29 Order 2014

The Oldham Failsworth Area Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though the waiting restrictions detailed in the Schedule below are included in the Principal Order at Part 1 Schedule 1

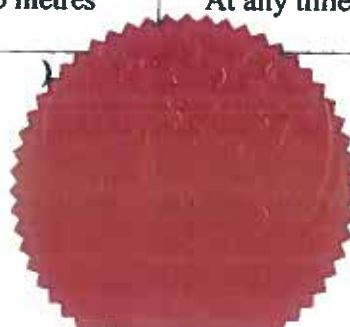
This Order shall be construed as one with the Principal Order.

✓	<u>Banbury Road</u> (Both sides) Extending from its junction with Green Lane for its full length up to and including its cul-de-sac end	At any time	A1, B1, B3, B4, C, E, K3	
✓	<u>Ledbury Road</u> (North side) From its junction with Banbury Road for a distance of 20 metres in an easterly direction	At any time	A1, B1, B3, B4, C, E, K3	
✓	<u>Ledbury Road</u> (South side) From its junction with Banbury Road for a distance of 5 metres in an easterly direction	At any time	A1, B1, B3, B4, C, E, K3	
✓	<u>Green Lane</u> South side From a point 7 metres west of Banbury Road to a point 15 metres east of Banbury Road	At any time	A1, B1, B3, B4, C, E, K3
