THE OLDHAM – OLDHAM AREA CONSOLIDATION ORDER CAR PARKING AMENDMENT No 126 ORDER 2014

The Oldham Borough Council on 18TH November 2014 made an Order under the Road Traffic Regulation Act 1984, as amended, the effect of which is to:-

Amend the charging scales on the Oldham Town Centre car parks to continue the 3 hour free car parking on Saturday and Sunday and on Hobson Street free on Saturday and Sunday and

Amend the Articles and Definitions in the current order to provide for a Pay and Display Ticket to be obtained and exhibited for the entire time the vehicle is left in the parking place whether a fee is payable or not and

Amend the charging scales for the 'On Street' parking to continue the 30 minutes free parking on Monday to Saturday and

Amend the maximum period of waiting on Tommyfield Car Park to 3 hours and the period of 3 hours must elapse from the time of leaving before a vehicle may return to the car park and

Amend the maximum period of waiting and period of no return on the Uppermill Car Parks to:-Saddleworth Museum - 3 hours maximum stay and no return within 3 hours

Smithy Lane - 2 hours maximum stay and no return within 2 hours

Hare and Hounds - 1 hour maximum stay and no return within 1 hour

King George V Playing Fields - 3 hours maximum stay and no return within 3 hours and

Amend the daytime scale on the Civic Centre Car Park to extend from 6pm to 7pm

NB There is no increase in the scales of charges

The Order will come into operation on 18th November 2014

A copy of the Order and a map showing the lengths of roads referred to and a copy of the Council's statement of reasons may be examined at my office between the hours of 8.40am and 5.00pm on Mondays to Fridays (Civic Reception, Civic Centre, West Street, Oldham, Telephone 0161 770 4836 Ref: LJM/TO14/23).

If you wish to question the validity of the Order or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from the date hereof apply to the High Court for the purpose.

THE OLDHAM - OLDHAM AREA CONSOLIDATION ORDER CAR PARKING AMENDMENT No 126 ORDER 2014

The Oldham Borough Council in exercise of its powers under Section 32 of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- This Order shall come into operation on 18th November 2014 and may be cited as the Oldham - Oldham Area Consolidation Order Car Parking Amendment No 126 Order 2014
- 2. The Oldham Oldham Area Consolidation Order 2003, The Oldham Royton Area Consolidation Order 2003, The Oldham Saddleworth Area Consolidation Order 2003, The Oldham Failsworth Area Consolidation Order 2003, The Oldham Lees Area Consolidation Order 2003, The Oldham Consolidation Order 2003, The Oldham Crompton Area Consolidation Order 2003 as amended (which Orders is hereinafter referred to as the "Principal Orders") shall have effect as though:-
 - Articles 25, 26, 27 and 28 be amended as set out in the First Schedule below
 - Articles 47, 48 and 49 shall be amended as set out in the First Schedule below
 - Article 73 be amended as set out in the First Schedule below to include 73 (3)
 - Definitions 10 and 54 of General Definitions shall be amended as set out in the Second Schedule below

Part II Schedule 5c as detailed in the Third Schedule below shall be introduced into The Oldham Area Consolidation Order 2003 and the Off Street Parking Places detailed in the Fourth Schedule below be removed from Part II Schedule 5a and immediately inserted into Part II Schedule 5c which will include the amendment of the maximum period of waiting on Tommyfield Market Car Park from 2 hours to 3 hours

The Parking Places Scales (On Street) as detailed in the Fifth Schedule below shall be deleted from the Oldham Area Consolidation Order 2003 at Part II Schedule 6B and replaced with the Parking Places Scales (On Street) as detailed in the Sixth Schedule below

Part II Schedule 5ba Parking Places Scales (Off Street) as detailed in the Seventh Schedule below shall be included in the Oldham Area Consolidation Order 2003 at part II

The Uppermill Parking Places detailed in the Eighth Schedule below shall be deleted from Part II Schedule 5a and introduced into Part II Schedule 5c as detailed in the Ninth Schedule below with the amended Maximum Period of Waiting and Time to elapse from time of leaving before the Vehicle can be returned to the Parking Place set out in columns 5 and 8 respectively of Schedule 5c in the Ninth Schedule below

This Order shall be construed as one with the Principal Orders.

FIRST SCHEDULE

Articles to be deleted from Section 4 (Part II)

- 25. The area of land specified in the Column 2 of Schedule 5a to Part IV of this Order may be used, subject to the following provisions of this Order, as a Parking Place for such classes of vehicle and on such days and during such hours and on payment of such charges and conditions as are specified in relation to the area in this Order and in Schedule 5a to Part II
- 26. The driver of a vehicle shall:-
 - (a) unless the vehicle is displaying a valid parking permit issued by the Borough Council or is being used all as provided for in Articles 42 and 45, be required to pay the appropriate charge to permit the vehicle to wait in a Parking Place during the times detailed in the Column 4 of Schedule 5a to Part II: and
 - (b) not leave the vehicle in a Parking Place outside the operational times specified in Column 4 of Schedules 5a to Part IV: and
 - (c) not leave the vehicle in a Parking Place in excess of the period specified in Column 5 of Schedule 5a to Part IV. The vehicle shall not be returned to the Parking Place before a period of one hour has elapsed from the time of leaving
- 27. No person shall leave a vehicle in a Parking Place without pay the appropriate charge specified in the Column 7 of Schedules 5a to Part II being paid in accordance with Article 26
- 28. The driver of a vehicle shall not cause or permit the vehicle to wait in the Parking Place unless it is of the specified class of vehicle described in the Column 3 of Schedule 5a to Part II

Articles to be included in Section 4 (Part II)

- 25. The area of land specified in the Column 2 of Schedules 5a and 5c to Part II of this Order may be used, subject to the following provisions of this Order, as a Parking Place for such classes of Vehicle and on such days and during such hours and on payment of such charges and conditions as are specified in relation to the area in this Order and in Schedules 5a and 5c to Part II
- 26. The Driver of a Vehicle shall:-
 - (a) unless the Vehicle is displaying a valid parking permit issued by the Borough Council or is being used all as provided for in Articles 42 and 45, be required to pay the appropriate Charge to permit the Vehicle to wait in a Parking Place during the times detailed in the Column 4 of Schedules 5a and 5c to Part II: and
 - (b) not leave the Vehicle in a Parking Place outside the operational times specified in Column 4 of Schedules 5a and 5c to Part II: and

- (c) not leave the Vehicle in a Parking Place in excess of the period specified in Column 5 of Schedule 5a and 5c to Part II.
- (d) in respect of the Parking Places detailed in Schedule 5A to Part II not return the Vehicle to the Parking Place before a period of one hour has elapsed from the time of leaving the Parking Place
- (e) in respect of the Parking Places detailed in Schedule 5C to Part II not return the Vehicle to the Parking Place before the period of time specified in Column 8 of Schedule 5c of Part II has elapsed from the time of leaving the Parking Place
- 27. No person shall leave a Vehicle in a Parking Place without paying the appropriate Charge specified in Column 7 of Schedules 5a and 5c to Part II being paid in accordance with Article 26
- 28. The Driver of a Vehicle shall not cause or permit the Vehicle to wait in the Parking Place unless it is of the specified class of vehicle described in Column 3 of Schedules 5a and 5c to Part II

THIRD SCHEDULE

Articles to be deleted from Section 4 (Part II)

PARKING PLACES (OFF STREET)

- 47. Amount and Method of Payment of The Charge and Display of Tickets
 - a) Except for vehicles referred to in Articles 42, 45 and 46 of this Order the charge for a vehicle left in the parking place will be that specified in Column 4 of Schedule 5a to Part II at the Scale specified in Column 2 of Schedule 5b in relation to the period of waiting specified in Column 3 of that Schedule. The Scale of Charges 5 and 5A shall apply only to Disabled Persons Vehicle with a Disabled Persons Badge displayed in the Relevant Position
 - b) In so far as a vehicle is left during charging hours in a Pay and Display Parking Place except for the charges payable in accordance with Article 44, the charge specified in Article 47 (a) of this Order shall be payable either on leaving the vehicle in the parking place by the insertion in the ticket machine provided in the parking place (being a machine, apparatus or device approved by the Secretary of State for Transport for such purposes) a coin or coins, notes or payment, or any payment method subsequently adopted by the council of at least to the value specified on the ticket machine: or
 - c) Except for vehicles left in accordance with Article 47(e) and (f) payment of the charge for the vehicle left in the parking bay shall be indicated by the issue of a numbered ticket from the ticket machine which indicated that the charge has been paid and the day and the time and by exhibition of that ticket in the manner specified in Paragraph (d) of this Article
 - d) Upon payment of the charge for the vehicle the driver thereof shall exhibit on the vehicle the ticket issued by the ticket machine or in the case of a driver who is the

holder of a contract with the Council in accordance with Article 44 above, a parking permit, by affixing the ticket or parking permit to the inside surface of the windscreen so that it is facing forwards and the time, date, payment and other details on the face of the ticket or permit can be easily seen from the front of the vehicle.

48. Amount of Penalty Charge

a) If a Vehicle is left in the Parking Place specified in the Schedule attached:

i. Where no parking payment ticket is purchased or exhibited on the vehicle in accordance with Article 47 of this Order; or

49. Manner of Payment of Penalty Charge

a) The penalty charge shall be paid to the Council either by cash, cheque, banker's draft, money order or postal order, telephone or any payment method subsequently adopted by the Council which shall be delivered or sent by post, or transmitted electrically or by telegraphic means so as to reach the Parking Shop of the Council on or before a period of 28 days beginning with the date of the notice. If the penalty charge is paid before a period of 14 days beginning with the date of the notice the penalty charge shall be reduced by the specified proportion. There shall be no allowance in the payment periods for the working practices of the Council's Parking Shop in respect of working hours, working days and Bank Holidays

Articles to be included in Section 4 (Part II)

PARKING PLACES (OFF STREET)

47. Amount and Method of Payment of The Charge and Display of Tickets

- a) Except for vehicles referred to in Articles 42, 45 and 46 of this Order the Charge for a Vehicle left in the parking place will be that specified in Column 4 of Schedule 5a and 5c to Part II at the Scale specified in Column 2 of Schedule 5b and 5ba in relation to the period of waiting specified in Column 3 of that Schedule. The Scale of Charges 5 and 5A shall apply only to Disabled Persons Vehicle with a Disabled Persons Badge displayed in the Relevant Position
- b) In so far as a Vehicle is left during charging hours in a Pay and Display Parking Place except for the charges payable in accordance with Article 44, the Charge specified in Article 47 (a) of this Order shall be payable either on leaving the Vehicle in the Parking Place by the insertion in the Ticket Machine provided in the Parking Place (being a machine, apparatus or device approved by the Secretary of State for Transport for such purposes) a coin or coins, notes or payment, or any payment method subsequently adopted by the Council of at least to the value specified on the Ticket Machine: or

- ba) Where a Vehicle is left during charging hours in a Pay and Display Parking Place and the Charge specified in Article 47 (a) of this Order is 'Free' a numbered ticket must be obtained from the Ticket Machine provided in the Parking Place and the ticket must be exhibited in accordance with paragraph (d) of this Article
- c) Except for vehicles left in accordance with Article 47(e) and (f) payment of the charge for the vehicle left in the Parking Place shall be indicated by the issue of a numbered ticket from the Ticket Machine which indicated that the Charge has been paid and the day and the time and by exhibition of that ticket in the manner specified in Paragraph (d) of this Article at all times during which the Vehicle is left in the Parking Place
- d) Upon payment of the Charge for the Vehicle the Driver thereof shall exhibit on the Vehicle the ticket issued by the Ticket Machine or in the case of a Driver who is the holder of a contract with the Council in accordance with Article 44 above, a parking permit, by affixing the ticket or parking permit to the inside surface of the windscreen so that it is facing forwards and the time, date, payment and other details on the face of the ticket or permit can be easily seen from the front of the Vehicle at all times during which the Vehicle is left in the Parking Place

48. Amount of Penalty Charge

a) If a Vehicle is left in the Parking Place specified in the Schedule attached:

i. Where no parking payment ticket (including a Parking Ticket issued in accordance with Article 47 (ba) is purchased or exhibited on the Vehicle in accordance with Article 47 of this Order; or

49. Manner of Payment of Penalty Charge

b) The penalty charge shall be paid to the Council either by cheque, banker's draft, money order or postal order, telephone or any payment method subsequently adopted by the Council which shall be delivered or sent by post, or transmitted electrically or by telegraphic means so as to reach the Parking Shop of the Council on or before a period of 28 days beginning with the date of the notice. If the penalty charge is paid before a period of 14 days beginning with the date of the notice the penalty charge shall be reduced by the specified proportion. There shall be no allowance in the payment periods for the working practices of the Council's Parking Shop in respect of working hours, working days and Bank Holidays

Article to be included in Section 5 (Part II)

(PARKING PLACES (ON STREET PAY AND DISPLAY)

73. (3) Where the Charge referred to in Paragraph (1) of this Article is 'Free' a Parking Ticket must be obtained from a Ticket Machine and displayed in accordance with Article 71 of this Order

SECOND SCHEDULE

10 "The Charge" means the appropriate charge to be paid by the driver of a vehicle using the parking place in accordance with Column 7 of Schedule 5a Part II

54 "Scale" being the Rate of Charge specified in Column 7 of Schedule 5a in relation to the Location of Parking Place in Schedule 5a and the number shown in Column 2 of Schedule 5b indicating the necessity to pay the charge in relation to the period of waiting during the controlled hours specified in Column 3 of Schedule 5b
