**THE OLDHAM - ROYTON AREA CONSOLIDATION ORDER
AMENDMENT NO 23 ORDER 2012**

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 2 April 2012 and may be cited as the Oldham – Royton Area Consolidation Order Amendment no 23 Order 2012.
2. The Oldham – Royton Area Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though the entries details in the First Schedule hereto are deleted from Principal Order and replaced with the entries detailed in the Second Schedule hereto at Part II Schedule 5a from the date hereof
3. This Order shall be construed as one with the Principal Order.

THE OLDHAM ROYTON PRECINCT & KING STREET CAR PARK TRAFFIC ORDER 2012

The Oldham Borough Council, have today made an Order under the Road Traffic Regulation Act 1984, as amended, the effect of which is to increase the maximum period of waiting from 3 hours to 18 hours on Royton Precinct car park, Radcliffe Street and to reduce the maximum period of waiting from 18 hours to 3 hours with a minimum period of no return of 3 hours on Monday to Friday 8.00 am to 6.00 pm on King Street car park Radcliffe Street

The Order will come into operation on 2ND April 2012

A copy of the Order and a map showing the lengths of road referred to and a copy of the Council's statement of reasons may be examined at my office between the hours of 8.40am and 5pm Monday to Friday (Civic Entrance), Civic Centre, West Street, Oldham, Telephone 0161 770 4836 Ref: LJM/TO 38/11).

If you wish to question the validity of the Order or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from the date hereof apply to the High Court for the purpose.
