**THE OLDHAM – OLDHAM AREA CONSOLIDATION ORDER RESIDENTS
ONLY PARKING & PARKING PLACES OFF STREET
AMENDMENT No 132 ORDER 2015**

The Oldham Borough Council in exercise of its powers under Section 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulations Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

This Order shall come into operation on 30th March 2015 and may be cited as the Oldham – Oldham Area Consolidation Order Residents Only Parking & Parking Places Off Street Amendment No 132 Order 2015

The Oldham – Oldham Area Consolidation Order 20013 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though the Parking Places (Off Street) detailed in the First Schedule below are included in the Principal Order at Part II Schedule 5a and the Residents Parking Zone detailed in the Second Schedule below is included in the Principal Order at Part II Schedule 3b from the date hereof

This Order shall be construed as one with the Principal Order.

PLACES OFF STREET AMENDMENT ORDER 2015**

**CARLTON WAY AREA EXTENSION OF RESIDENTS PARKING ZONE INCLUDING THE
OLDHAM ROAD CAR PARK**

The Oldham Borough Council, have today made an Order under the Road Traffic Regulation Act 1984, as amended, the effect of which is to extend the Residents Only Parking Zone on Monday to Saturday 8am to 8pm on both sides of Carlton Way from its junction with Hilbre Avenue to its junction with Berkley Drive and on both sides and the whole lengths of Strand Way, Mayfair Drive, Westbury Way, Grosvenor Way, Palace Gardens, Downham Close, Hilbre Avenue and Arlington Close and introduce Off Street Parking Places on the The Oldham Road Car Park which on Monday to Saturday from 8am and 8pm will be included in the Residents Only Parking Scheme.

From 8pm to 8am on Monday to Saturday and for 24 hours on Sunday the Oldham Road Car Park will be available for use by all vehicles

The Order will come into operation on 30th March 2015

If you wish to question the validity of the Order or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from the date hereof apply to the High Court for the purpose.
