# THE OLDHAM - OLDHAM AREA CONSOLIDATION PROHIBITON OF WAITING ORDER AMENDMENT NO 115 ORDER 2014

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- This Order made 10<sup>th</sup> January 2014 shall come into operation on 10<sup>th</sup> January 2014 and may be cited as the Oldham – Oldham Area Consolidation Order Prohibition of Waiting Amendment No 115 Order 2014
- 2. The Oldham Oldham Area Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though the 'At any Time' waiting Part 1 Schedule 1 and the Parking Places (on street) detailed in the Second Schedule below are deleted from the Principal Order at below are deleted from the Principal Order at Part II Schedule 6 and the Parking Places (on street) detailed in the Third Schedule below are included in the Principal Order Part II Schedule 6 from the date hereof.
- This Order shall be construed as one with the Principal Order.
