**THE OLDHAM CHADDERTON AREA CONSOLIDATION ORDER PROHIBITION OF  
WAITING AMENDMENT ORDER 2014**

**BLOCK LANE CHADDERTON AREA**

The Oldham Borough Council, have today made an Order under the Road Traffic Regulation Act 1984, as amended, the effect of which is to introduce at any time waiting restrictions on the west side of Block Lane from its junction with Robinson Street for a distance of 28 metres in a northerly direction and on the west side of Block Lane from its junction with Robinson Street for a distance of 35 metres in a southerly direction and on the east side of Block Lane from a point 10 metres south of its junction with Ridings Way for a distance of 115 metres in a northerly direction and on both sides of Ridings Way from its junction with Block Lane for a distance of 25 metres in an easterly direction and on both sides of the unnamed road from its junction with Block Lane for a distance of 10 metres in an easterly direction and on the north side of Robinson Street from its junction with Block Lane for a distance of 15 metres in a westerly direction and on the south side of Robinson Street from its junction with Block Lane for a distance of 40 metres in a westerly direction and on the west side of Agnes Street from its junction with Robinson Street for a distance of 37 metres in a south westerly direction and on the east side of Agnes Street from its junction with Robinson Street for a distance of 47 metres in a south westerly direction.

The Order will come into operation on 10<sup>th</sup> January 2014 .

If you wish to question the validity of the Order or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from the date hereof apply to the High Court for the purpose.

**THE OLDHAM - CHADDERTON AREA CONSOLIDATION ORDER PROHIBITION OF  
WAITING AMENDMENT NO 36 ORDER 2014**

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order made 10<sup>th</sup> January 2014 shall come into operation on 10<sup>th</sup> January 2014 and may be cited as the Oldham – Chadderton Area consolidation Order Prohibition of Waiting Amendment No 36 Order 2014
2. The Oldham – Chadderton Area Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though the "At Any Time" waiting restrictions detailed in the Schedule below are included in the Principal Order at Part 1 Schedule 1 from the date hereof
3. This Order shall be construed as one with the Principal Order.

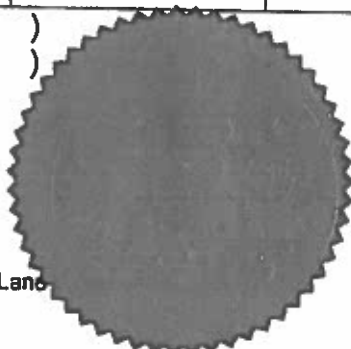
