**THE OLDHAM - CHADDERTON AREA CONSOLIDATION ORDER PROHIBITION OF WAITING
AMENDMENT NO 31 ORDER 2013**

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 7th January 2013 and may be cited as the Oldham – Chadderton Area Consolidation Order Prohibition of Waiting Amendment No.31 Order 2013
2. The Oldham – Chadderton Area Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though the waiting restrictions detailed in the First Schedule hereto are deleted from the Principal Order at Part 1 Schedule 1 and replaced with the waiting restrictions detailed in the Second Schedule hereto and the limited waiting detailed in the Third Schedule hereto are included in the Principal Order at Part 1 Schedule 2
3. This Order shall be construed as one with the Principal Order.

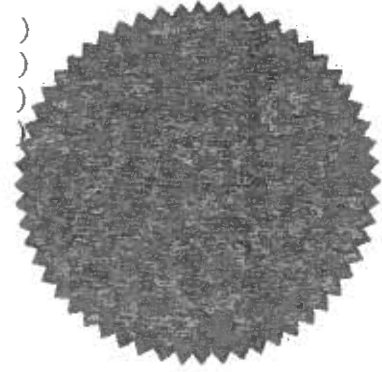
