**THE OLDHAM - SADDLEWORTH AREA CONSOLIDATION ORDER
PROHIBITION OF WAITING
AMENDMENT No 40 ORDER 2015**

The Oldham Borough Council in exercise of its powers under Section 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulations Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

1. This Order shall come into operation on 27th August 2015 and may be cited as the Oldham – Saddleworth Area Consolidation Order Prohibition of Waiting Amendment No 40 Order 2015
2. The Oldham - Saddleworth Area Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though the waiting restrictions detailed in the Schedule below are included in the Principal Order at Part 1 Schedule 1
3. This Order shall be construed as one with the Principal Order.
