**ROAD TRAFFIC REGULATION ACT 1984**

**THE OLDHAM – CHADDERTON AREA CONSOLIDATION ORDER  
PROHIBITION OF WAITING & LOADING AMENDMENT No 41 ORDER 2015**

The Oldham Borough Council in exercise of its powers under Section 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulations Act 1984, as amended, (“the Act”) and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

1. This Order shall come into operation on 27<sup>th</sup> August 2015 and may be cited as the Oldham – Chadderton Area Consolidation Order Prohibition of Waiting & Loading Amendment No 41 Order 2015
2. The Oldham – Chadderton Area Consolidation Order 2003 (which Order is hereinafter referred to as the “Principal Order”) shall have effect as though the waiting and loading restrictions detailed in the Schedule below are included in the Principal Order at Part 1 Schedule 1 from the date hereof
3. Entry 4 of The Chadderton (Various Roads) (No Waiting) (No4) Order 1969 is hereby revoked (No Waiting Monday to Saturday 7am-7pm on Foxdenton Lane from its junction with Broadway to its junction with the un-named street between 242 and 244 Foxdenton Lane)
4. This Order shall be construed as one with the Principal Order.
