**THE OLDHAM – OLDHAM AREA CONSOLIDATION ORDER PROHIBITION
OF WAITING & LOADING AMENDMENT No 139 ORDER 2015**

The Oldham Borough Council in exercise of its powers under Section 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulations Act 1984, as amended, (“the Act”) and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

1. This Order shall come into operation on 27th August 2015 and may be cited as the Oldham – Oldham Area Consolidation Order Prohibition of Waiting & Loading Amendment No 139 Order 2015
2. The Oldham – Oldham Area Consolidation Order 2003 (which Order is hereinafter referred to as the “Principal Order”) shall have effect as though the waiting and loading restrictions detailed in the First Schedule below are deleted from the Principal Order at Part 1 Schedule 1 and replaced with the waiting and loading restrictions detailed in the Second Schedule below
3. This Order shall be construed as one with the Principal Order.
