

OLDHAM BOROUGH COUNCIL**ROAD TRAFFIC REGULATION ACT 1984****THE OLDHAM – CROMPTON AREA CONSOLIDATION ORDER PROHIBITION OF WAITING & LOADING AMENDMENT No 41 ORDER 2015**

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order made on 12th November 2015 shall come into operation on 16th November 2015 and may be cited as the Oldham – Crompton Area Consolidation Order Prohibition of Waiting & Loading Amendment No 41 Order 2015
2. The Oldham Crompton Area Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though the waiting restrictions detailed in the First Schedule below are deleted from the Principal Order at Part 1 Schedule 1 and replaced with the waiting and loading restrictions detailed in the Second Schedule below from the date hereof.
3. This Order shall be construed as one with the Principal Order.
