# THE OLDHAM – ROYTON AREA CONSOLIDATION ORDER PROHIBITION OF WAITING AMENDMENT No.38 ORDER 2016

The Oldham Borough Council in exercise of its powers under Section 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulations Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

- This Order made on 24<sup>th</sup> March 2016 shall come into operation on 29<sup>th</sup> March 2016 and may be cited as the Oldham Royton Area Consolidation Order Prohibition of Waiting Amendment No 38 Order 2016
- 2. The Oldham Royton Area Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though the waiting restrictions detailed in the First Schedule below are deleted from the Principal Order at Part 1 Schedule 1 and replaced with the waiting restrictions detailed in the Second Schedule below from the date hereof.
- 3. This Order shall be construed as one with the Principal Order.
