ROAD TRAFFIC REGULATION ACT 1984

THE OLDHAM BOROUGH COUNCIL (OLDHAM TOWN CENTRE TRAFFIC REGULATION ORDER 1988) (AMENDMENT) ORDER 2016

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 14th October 2016 and may be cited as the Oldham Borough Council (Oldham Town Centre Traffic Regulation Order 1988) (Amendment) Order 2016.
2. The Oldham Borough Council Oldham Town Centre Traffic Regulation Order 1988 (the "Principal Order") shall have effect as though the provisions contained in Schedules 1 and 2 to this Order were deleted from the Principal Order and the provisions contained in Schedules 3 and 4 to this Order were inserted into the Principal Order.
3. The Principal Order shall be amended by the insertion of the additional Articles and Schedules 15 and 16 as detailed in Schedule 4.
4. The Order specified in Column 1 of Schedule 5 is revoked to the extent specified in Column 2 of the said Schedule.
5. This Order shall be construed as one with the Principal Order.

High Street	From the western side of its junction with Lord Street to its western junction with Church Terrace

PROHIBITION OF ENTRY EXCEPT FOR PUBLIC SERVICE VEHICLES Schedule 10

Road	Length	Direction of Entry
High Street	At its western junction with Church Terrace	Westbound
Lord Street	At a point 8 metres north of its junction with High Street	Southbound

Yorkshire Street	from its junction with High Street to its junction with St Mary's Way	Easterly direction

SCHEDULE 4

AMENDMENTS TO THE PRINCIPAL ORDER

Insert the following wording after Article 15 of the Principal Order:

- 15A. In this Article and in Articles 15B and 15C and Schedule 15, the word "Permit" means a permit issued by the Council to allow vehicles to enter Firth Street, Oldham. Applications for a Permit shall be made on a form issued by and obtainable from the Council and shall include the information required by the form.
- 15B. The Council may at any time require an applicant for a Permit to produce to an Officer of the Council such evidence in respect of an application for a Permit made to it as it may require to verify any information given to it.
- 15C. No person shall, except upon the direction or with the permission of a police constable in uniform or of a civil enforcement officer, cause or permit any vehicle other than a vehicle displaying a Permit to enter or wait in the lengths of road specified in Column 1 of Schedule 15 to this Order to the extent specified in Column 2 of the said Schedule. For the purposes of this Article, a Permit is displayed on a vehicle if it relates to the vehicle described in the Permit and it is displayed in the bottom left hand corner of its windscreen.

- 15D. No person shall, except upon the direction or with the permission of a police constable in uniform or of a civil enforcement officer, cause or permit any vehicle (except public service vehicles) to enter or wait at any time in the lengths of road specified in Column 1 of Schedule 16 to this Order to the extent specified in Column 2 of the said Schedule except for the purpose of access to premises situated on Church Terrace and or Church Street, Oldham.

Insert the following wording after Article 21 of the Principal Order:

22. The provisions of Article 18 shall apply to Articles 15C and 15D

Insert the following Schedules after Schedule 14 of the Principal Order:

NO ENTRY EXCEPT PERMIT HOLDERS
