THE OLDHAM – FAILSWORTH AREA CONSOLIDATION ORDER PROHIBITION OF WAITING AMENDMENT No 38 ORDER 2016

The Oldham Borough Council in exercise of its powers under Section 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulations Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

1. This Order made on 24th August 2016 shall come into operation on 30th August 2016 and may be cited as the Oldham – Failsworth Area Consolidation Order Prohibition of Waiting Amendment No 38 Order 2016
2. The Oldham – Failsworth Area Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though the waiting restrictions detailed in the Schedule below are included in the Principal Order at Part 1 Schedule 1 from the date hereof.
3. This Order shall be construed as one with the Principal Order.

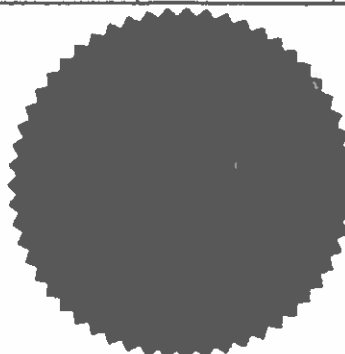
