**THE OLDHAM - FAILSWORTH CONSOLIDATION ORDER PROHIBITION OF WAITING  
AND RESIDENTS PARKING ZONE AMENDMENT No 39 ORDER 2016**

The Oldham Borough Council in exercise of its powers under Sections 1(1), 2(1), 2(2) and 4(2) of the Road Traffic Regulation Act 1984, as amended, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order made on 19<sup>th</sup> October 2016 shall come into operation on 24<sup>th</sup> October 2016 and may be cited as the Oldham – Failsworth Area Consolidation Order Prohibition of Waiting and Residents Parking Zone Amendment No 39 Order 2016
2. The Oldham – Failsworth Area Consolidation Order 2003 (which Order is hereinafter referred to as the "Principal Order") shall have effect as though the waiting restrictions detailed in the First Schedule below are deleted from the Principal Order at Part I Schedule I and the waiting restrictions detailed in the Second Schedule below are included in the Principal Order at Part I Schedule I and the Residents Parking Zone detailed in the Third Schedule below is included in the Principal Order at Part II Schedule 3b from the date hereof
3. This Order shall be construed as one with the Principal Order.

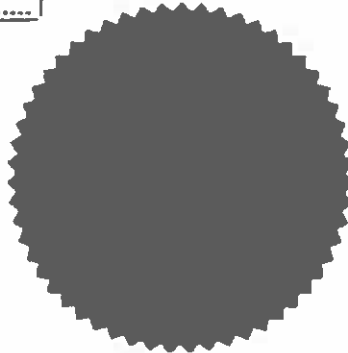
