THE OLDHAM – OLDHAM TOWN CENTRE TEMPORARY PROHIBITION OF DRIVING FOR ALL MOTOR VEHICLES/PROHIBITION OF WAITING/PROHIBITION OF LOADING ORDER 2023

The Oldham Borough Council in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984, as amended, and of all other enabling powers hereby make the following Order:-

- This Order made on 12th December 2023 shall come into operation on the 13th December 2023 and may be cited as The Oldham – Oldham Town Centre Temporary Prohibition of Driving for All Motor Vehicles/Prohibition of Waiting/Prohibition of Loading Order 2023 and will continue in force until the 12th June 2025
- 2. In this Order the following words shall have the following meanings:-
 - "Commercial Vehicle" means a Motor Vehicle constructed for the conveyance of goods or merchandise, or for the conveyance of materials used in any trade, business, industry or work whatsoever, other than a Motor Vehicle for the conveyance of passengers, and includes any Motor Vehicle that is designed primarily for the carriage of persons, but which has been fitted or adapted for the conveyance of goods, merchandise or materials used in any trade, business, industry or work whatsoever, and which is in fact used for that purpose
 - "Cycle" means a cycle as defined in Section 192(1) of the Road Traffic Act 1988
 - "Emergency Vehicle" means a vehicle being used for fire, police or ambulance purposes
 - "Motor Vehicle" means a mechanically propelled vehicle intended or adapted for use on roads
 - "Permit Holder" means the holder of a Permit issued by Oldham Council Parking Services
- Save as provided in Article 4 no person, except upon the direction or with the permission of a police officer in uniform, shall cause or permit any Motor Vehicle to proceed along any of the lengths of road specified in Schedule 1 to this Order.
- 4. Nothing in Article 3 shall apply to a Cycle or an Emergency Vehicle.
- 5. Article 3 shall not apply to a Commercial Vehicle or Permit Holder that is loading or unloading between the hours of 5pm and 10am daily

- 6. No person shall cause any Motor Vehicle to wait at any time in any of the lengths of road specified in Schedule 2 to this Order
- 7. No person shall cause any Motor Vehicle to load or unload at any time in any of the lengths of road specified in Schedule 3 to this Order
- 8. Article 7 shall not apply to a Commercial Vehicle or Permit Holder that is loading or unloading between the hours of 5pm and 10am daily
