**THE OLDHAM – RETIRO STREET/QUEEN STREET/YORKSHIRE STREET
ONE-WAY ORDER & RETIRO STREET PROHIBITION OF RIGHT TURN ORDER 2019**

The Oldham Borough Council in exercise of its powers under Sections Section 1(1), 2(1), 2(2), 4(2), & 9 of the Road Traffic Regulations Act 1984, as amended, (“the Act”) and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

1. This Order made on 7th May 2019 shall come into operation on 14th May 2019 and may be cited as the Oldham – Retiro Street/Queen Street/Yorkshire Street One-Way Order & Retiro Street Prohibition of Right Turn Order 2019
2. The One Way Traffic restrictions set out in the First Schedule below shall be deleted from Schedule 1 of The Oldham Borough Council (Oldham Town Centre) (Various Movement Traffic Regulation Orders) (Number 2) Order 2013
3. No person shall cause or permit any vehicle to proceed in the lengths of road specified in Column 1 of the Second Schedule to this Order in any direction other than the direction specified in relation to that length of road in Column 2 of the Second Schedule
4. No person shall cause or permit any vehicle proceeding along Retiro Street to turn right into Union Street. Every person causing or permitting any vehicle to proceed along Retiro Street shall on reaching the junction of Retiro Street and Union Street shall cause that vehicle to turn left onto Union Street
5. Nothing in this Order shall apply to a vehicle being used for fire brigade, ambulance or police purposes.

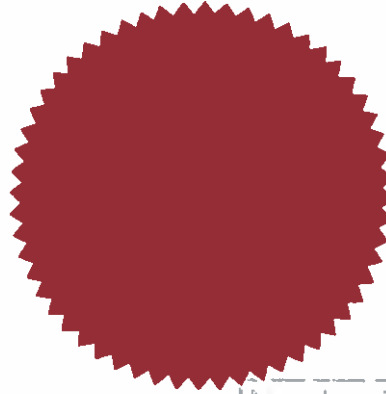
Column 1 Length of Road	Column 2 Permitted Direction

Queen Street – from its junction with Union Street to its junction with Yorkshire Street	Northerly direction
Yorkshire Street – extending from the western kerb line of St Mary's Way to the western kerb line of Old Church Street	Easterly direction
